Higher education data verification 2020


Verification of 2020 higher education data

- TCSI will be the source of the 2020 data set.
- A TCSI snapshot will be used for 2020 funding reconciliations, publications, and statistics.

The Past course completions reports – as all 2020 course completions data is submitted via HEPCAT, the source of truth for these reports will be HEIMS Online.






Accessing HELP information

- If you currently use HEIMS webservice this will continue to return your students entitlement balance (existing caveats) *
- If you use HEIMS Administration for entitlement information – you can access students entitlement information via myHELPbalance







The verification snapshot – what does it look like?



- 1. CSV file of unit record data
- Format = similar to current HEIMS Online structures for enrolment, load files
- 3. Key publication tables for your institution
 - Student enrolment
 - Student load



Student Load:

- Actual Student Load (EFTSL) for All Students by Liability Status and Broad Level of Course
- Amounts Charged, Paid Up-front, and Debt amount(a) by Loan type

Publishing 2020 course completions



Key message for course completions publications:

Don't stress!

- 12 weeks designates the number of weeks TCSI will keep trying automatically to verify a student's TFN without any action on your part.
- After 12 weeks you will need to update the student's data to trigger a reverification of their TFN.

Element 310 - new course of study type code

Adding Code 23 – undergraduate certificate

- This was introduced from 2021 to identify the new undergraduate certificates
- When undergraduate certificates were first introduced in 2020 as part of the COVID measures, code 22 was used to report these courses.
- Rules will not allow you to change a course of study type for an existing course- this includes a change from code 22 to 23

To help resolve this we are planning to:

- Provide you with a list of undergraduate
 certificate courses reported in 2020 using
 code 22
- Seek your confirmation that these courses are to be updated to code 23 in TCSI

You may choose to create new undergraduate certificate courses using code 23 from 2021






