Multifactor authentication for HEIMS Online

Re-cap on new method for accessing HEIMS Online

Why:

• Due to the recent changes made by the Australian Cyber Security Centre, Multi-Factor Authentication will be implemented to access HEIMS Online to protect the application from cyber threats.

For:

- HEIMS Legacy reports
- Program Funding Systems
 - CGS, HECS-HELP, FEE-HELP and OS-HELP
 - Institution Payment Information

Benefits:

- Providers can manage access in PRODA
- Removes the need to submit paper forms
- No more password resets



Preparing for Multi-factor Authentication

Key dates and information:

- 28 June Attributes for HEIMS Online released to PRODA.
- **9 July** HEIMS URL and user credentials will be active to this date.
- 10 July Multi-Factor Authentication and new subscription process for HEIMS Online will be released.
 - **☐** Provider impacts
 - > HEIMS credentials will no longer be required
 - HEIMS Online URL will be re-directed
 - Access to HEIMS Online will be through PRODA
 - ➤ Email addresses for July payment run will be sourced from HEIMS, thereafter sourced from new subscription method.

Accessing payment information and notifications

For continued access:

- To payment information:
 - ➤ Directors can start attributing roles to members ready for July payment run.
- To receive funding notifications:
 - ➤ New subscription process will be release
 - Subscribe by entering email address and select applicable funding program when accessing HEIMS Online through PRODA.
- Email subscriptions will be suspended:

 If a user has not accessed HEIMS Online for
 12 months.

2022 Higher Education Data Verification

2022 Higher Education Student Data Verification

Verification of 2022 Higher education student data has started and must be completed by **31 July 2023**.

Common queries received

Report/Collection	Query	TCSI Support advise
HDR EFTSL Report	Student has finished Scholarship 09 - RTP Fee Offset, during 2022 year, when drilling through the scholarship type an enrolment record is returned which is beyond the scholarship effective to date? Would the record be categorised as "No Scholarship"?	If a student has a valid RTP scholarship for the reporting year i.e., 2022, the HDR EFTSL Report will display the student against the reported scholarship type code of 09 - RTP Fee Offset regardless if the scholarship effective to date is prior to the census date. See HDR EFTSL report coding notes
All Reports that use Citizenship	What is the logic for determining the citizenship code of a student that changes citizenship status during an academic year?	If multiple citizenship values exist, the last citizenship record with the latest Effective from date (E609 - Effective from date) in the reporting year will be used in the report and drill through. See enrolment data report coding notes.

Learnings from 2021

Data Checking:

- Review and verify ALL reports
- If live data reports are loading slowly, try "Start verification" to view verification reports
- "Refresh" only when changes are made in your reported data

Less than 10%		Low
Between 10% and 30%		Intermediate
Greater than 30%		High

- Raise issues early
- No changes can be made after your signed-off reports are finalised
