

# Improvements to CHESSN allocation



# **CHESSN Allocation changes**

- Improved data matching for allocating CHESSNs
- Update to baseline data requirements
- Checks undertaken on USI and TFN
- Benefits & risks
- Update on a future release that relates to the reporting of CHESSNs

# Improved data matching for CHESSN allocation

CHESSN allocation process will now perform checks on the student's record having a verified USI or a verified TFN.

Previously the baseline data to find or allocate a CHESSN was:

- E313 Student identification code
- E314 Date of birth
- E402 Student family name
- E403 Student given name first
- E404 Student given name others
- E315 Gender code

To support identifying students accurately, the baseline data requirements now includes *either a verified* E416 - Tax file number or *a verified* E584 - Unique Student Identifier.

A CHESSN will not be allocated until either a TFN or a USI is verified.

# **Benefits & risks**

Benefits of having either a verified TFN or USI will

- Ensure that students with committed loans are uniquely identified in TCSI
- Students HELP entitlements are calculated correctly
- Reduce loan processing delays
- Reduce the number of identity errors and conflicts
- Reduce the number of CHESSNs changed after the look-up process, when a verified TFN becomes available

Risks of not having either a TFN or a USI verified will delay

- Calculation of Students HELP entitlements
- Prevents providers from accessing information on Students HELP entitlements
- Loans created will remain in unassessed state
- Prevents students accessing their entitlement information on MyHELPBalance

<u>CHESSN Management</u> webpage on <u>TCSI Support</u> has been updated to reflect this change and further information will be provided in our next newsletter.

# Future release - Reporting of CHESSNs not required

In a future release, providers are not required to report CHESSNs, if CHESSNs are reported they will be ignored. This change will not affect providers with reporting or updating student packets.

The assigning of a CHESSN onto a student's record is the responsibility of the department and with the recent work to improve the accuracy of identity matching, the reporting of CHESSNs by providers will soon be ignored by TCSI.

This change will apply to when a provider

• reports, amends or remove a CHESSN

Noting that when a CHESSN is amended, a new student identity assessment will not be triggered.

# Future release – New RTV - reporting of CHESSNs

A new warning RTV 11055 on Student Packet will be returned if a provider amends or reports a CHESSN.

We will delay implementation in production to allow sufficient time for vendors/providers to implement in their processes.

# **2023 HEP Student data verification**

## What's verification

• Verification is part of provider's reporting requirements under the *Higher Education Support Act 2023* (HESA). It is a declaration that the data reported for 2023 is complete, accurate and final.


## Why verification is important

- The department uses the verified data to reconcile your funding and to publish information on your organisation, including data on course completions and success rates.
- The verification process gives you a final opportunity to check your data carefully, as changes cannot be made to the 2023 dataset after verification is finalised.

#### Data Verification

Verification is a declaration that the student and staff data reported by providers to the department is complete, accurate and finalised.

To access relevant data verification information and instructions, providers need to first determine their provider type. Providers who have been approved under the *Higher Education Support Act 2023(HESA)* can offer HELP loans. Non-HESA-approved providers cannot offer HELP loans and are considered to be TEQSA Provider Information Request (PIR) providers.

# 1. Background

- As part of the ongoing work to enhance the Student Learning Entitlement Management System (SLEMS), amendments to the processing of postgraduate and graduate entry bachelor courses were made to ensure only students enrolled in a Commonwealth Supported Place (CSP) as part of these courses are awarded Additional SLE (ASLE)
- This work has resulted in the creation of a new value in SLEMS called 'Provisional ASLE'
- Further work has been undertaken to create additional warning RTV's to help increase provider visibility and assist them in managing the SLE policy



# 2. What is Provisional ASLE?

- Provisional ASLE is a placeholder value that is awarded to a student when they enrol in a postgraduate or graduate entry bachelor course (E310 = 04, 05, 06, 07, 08, 11, 12 or 14) where no CSP unit has been reported against it.
- Provisional ASLE cannot be consumed by students, however when a CSP unit is linked to the course that awarded it, it will be transferred into the student's Additional SLE amount, allowing for Additional SLE consumption.
- Existing postgraduate and graduate entry bachelor courses have been reprocessed to align with the amendments to the Additional SLE workflow

# 7. Fixes to existing RTV's

- Also included in this piece of work is the release of fixes to errors preventing SLE amounts being recredited for units in some instances where the HELP Amount or Amount charged equals zero. These fixes include:
  - New <u>RTV 10921</u> and <u>RTV10922</u> which warns providers that the amount charged (E384) and HELP Loan Amount (E558) should be greater than \$0 for CSP units
  - Updated <u>RTV10462</u> which will block an attempt to report the remission of a non-CSP unit with an amount charged (E384) of \$0.
