Gender Code update



Gender codes (all providers)

- TCSI will be updated to align with the ABS statistical standard for Sex and gender.
- The e315: Gender Code will be updated to the following allowable values
- Providers can start using the new values in production from this Friday*, with the values becoming part of the reporting requirements for the 2026 student and staff collections

VALUE	
F	Female/Woman
M	Male/Man
N	Non-Binary
D	Different Term
P	Prefer not to answer

USI Verification Triggers update



USI Verification Triggers update

What are the changes?

- Changes have been made to the USI Verification process to better align with the TFN verification process.
 - 1. USI verification retry period has been increased from 6 to 12 weeks.
 - Patches to any student data will result in a finished USI verification period to restart, regardless of whether the patch results in any change of data.
 - 3. TCSI Outstanding Issue in Production #165485 (USI verification is only conducted once after being re-triggered after the verification period has concluded.) has been addressed.



USI Verification Notifications Update

What are the changes?

- New SV00127 has been introduced to replace 8 previous scheduled validations.
- Cut down on the number of USI related scheduled validations providers receive for a single student.
- Streamlining process of addressing genuine USI errors in TCSI.

First address update



First address (HE providers)

- The migration from HEIMS to TCSI caused some incorrect postcodes for first address.
- To fix the issue, the department has previously rectified this manually. This will cease in 2024.
- The University Statistics team emailed providers regarding action that is required.
- The action is to check TCSI first addresses match those in your student management systems.

First address (HE providers)

FAQs

- There will be no changes to historical data or funding.
- The fix implemented by the department was fixing poor quality of data migrated from HEIMS.
- The fix impacts the reported First Address regional and remote data only.
- Data can be requested which shows which students were impacted to narrow the action if necessary.
- The department expects First Address information for all domestic students to be accurate.
- First Address should be a residential address, not a PO Box.

2024 HEP Student data verification

What's data verification?

• Data verification is part of a provider's reporting requirements under the *Higher Education Support Act 2003* (HESA). It is a declaration that the data reported are accurate.


Why is data verification important?

- The department uses the verified data to reconcile your funding and to publish information on your organisation, including data on course completions and success rates.
- The verification process gives you a final opportunity to check your data carefully, as changes cannot be made to your 2024 Student verified data after it is signed off and finalised.

Data Verification

Verification is a declaration that the student and staff data reported by providers to the department is complete, accurate and finalised.

To access relevant data verification information and instructions, providers need to first determine their provider type. Providers who have been approved under the *Higher Education Support Act 2003 (HESA)* can offer HELP loans. Non-HESA-approved providers cannot offer HELP loans and are considered to be TEQSA Provider Information Request (PIR) providers.

Key takeaways

Data checking:

You must review and verify ALL verification reports before sign off

Remember:

- Data needs to be accurate before signing off the Collection(s).
- No changes can be made after your verification reports are signed off and the Collections are finalised by the department.

- The RFI is designed to understand your submission and verification plans
- To confirm primary and secondary TCSI contacts for your student data collection and maintain our provider contact record

Higher Degree by Research (HDR) reports




Research Training Program



The RTP provides \$1.25 billion annually in block grants to eligible HEPs to support higher degree by research (HDR) students by the provision of RTP scholarships.

RTP funding is allocated based on a formula which considers a HEP's relative share of competitive research and development income, engagement research income and weighted HDR student completions.



The data verified via the HDR course completions report is used to calculate the **weighted HDR student completions** which are used in the RTP funding formula.

Outcome

- Providers can now view and verify RTP scholarship data in TCSI Analytics
- Drill downs are also available to view all RTP scholarship data

Changes to reporting E623 RTP stipend amount

- There has been inconsistency in the way that E623 RTP stipend amount has been reported for part-time students and students completing their studies before the end of the year.
- E623 RTP stipend amount is being changed so that all providers should report the annual full-time equivalent amount regardless of whether a student has completed their course part-time or completed their course early in the year.



Example A: A student commences their HDR studies in July 2024 and is studying full-time. They are awarded a RTP stipend and receive \$20,000 in their bank account in 2024. The annual full-time equivalent RTP stipend rate awarded to the student is \$40,000 in 2024. A RTP stipend rate of \$40,000 is reported in E693.



Example B: A student commences their HDR studies in January 2024 and is studying part-time. They are awarded a RTP stipend and receive \$20,000 in their bank account in 2024. The annual full-time equivalent RTP stipend rate awarded to the student is \$40,000 in 2024. A RTP stipend rate of \$40,000 is reported in E693.

Helpful hints – reporting E623 RTP stipend amount

Report the RTP stipend amount only

exclude any RTP allowances & RTP fees offset

Report the annual fulltime equivalent amount including when a student is part-time or completed their course early in the year

Exclude any form of top ups or co-contributions

such as other university funds, industry funds or other government funds
